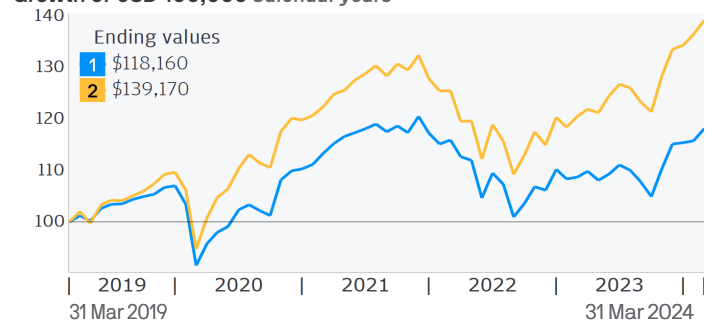

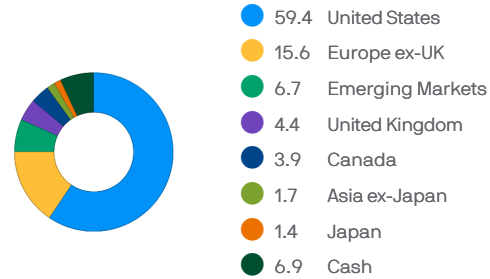

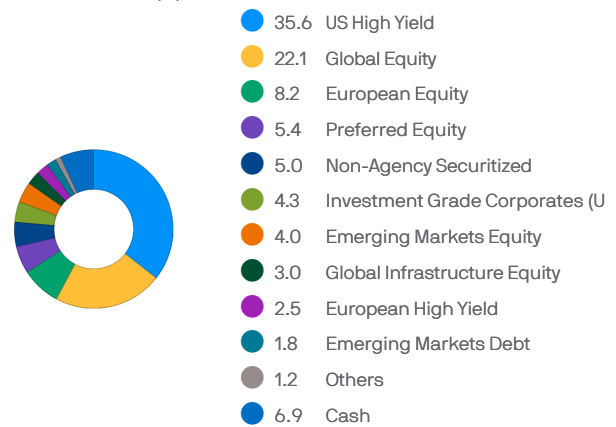

Definitions
